Description / Special Requirements	Single bed room for general mental health patients. Natural light and outlook is essential. The room is to be internally lockable with a master keyed lock from the outside. All fittings and fixtures used in consumer areas of the building must be of a type manufactured and marketed as anti-ligature; and installed in accordance with the manufacturer's instructions. Door and joinery hardware and any engineering services outlets must not provide ligature points and must be tamper proof. Selected fixtures are to have a breaking strain of not more than 15kg (e.g. clothes hooks). All glazing (including external windows) is to be Grade A safety glass to comply with AS/NZS 2208 and AS 1288, specifically, toughened laminated glass with a minimum thickness of 14.28mm, or equivalent approved. The 1 Bed Room - Mental Health may vary in configuration to suit different Ensuite options, including inboard and back to back. Staff to staff nurse call has not been provided on the assumption that a portable call and duress device is provided to staff. Consider location of wi-fi access points to ensure strong wi-fi coverage is provided for mobile duress functions. Jurisdictional policy to be read in conjunction with guidelines.
