Description / Special Requirements	A Seclusion Room provides for the sole confinement of a distressed or agitated person requiring separation for short periods at any hour of the day or night on an involuntary basis. An external outlook is required. All glazing (including external windows) is to be Grade A safety glass to comply with AS/NZS 2208 and AS 1288, specifically, toughened laminated glass with a minimum thickness of 14.28mm, or equivalent approved. Jurisdictional requirements may require an increase in the thickness of the glass for Seclusion Rooms. Door and joinery hardware and any engineering services outlets must not provide ligature points and must be tamper proof. General lighting must be dimmable and/or have controlled switching to create a low stimulus environment. An internal observation window is required so observation is optimised and blind spots eliminated. Designers must carefully consider the design of the door, to ensure it has sufficient strength and robustness but still allows for speech to be heard through it. All finishes to be flush and not provide ligature points. Consider location of wi-fi access points to ensure strong wi-fi coverage is provided for mobile duress functions. Jurisdictional policy to be read in conjunction with guidelines.
